Rental Agreement

Terms of agreement:

1. Room/Hall (Grounds) to be left in the same condition as was found before use.
(All tables and chairs to be returned to setup as was found)
2. No tape, staples, nails, thumbtacks, or pins to be put on walls or ceiling tiles. No paint to be used.
3. You will be responsible for any damage to Buildings, Grounds or any other of the GVFC property.
4. All garbage will be taken outside to the large collection containers by the front corner of the building.
5. There will be **NO** admittance to the Truck bays.
6. You will be responsible for any bodily injuries to yourself and your guests or the property of either. And agree not to hold the Gowanda Volunteer Fire Company responsible in any way.
7. Use of the kitchen is included in this agreement. The kitchen will be left in a clean and orderly manner. Failure to clean and put away any dishes used could cost you your security. Food or other consumable items (paper products) are not to be used. (Except coffee filters)
8. The Renter signing this agreement must be at least 21 years of age and **MUST** be on the premises during the time of the rental. (Responsible Party)
9. There will be no smoking inside of the building. Please dispose of all cigarette butts in the provided containers.
10. There may be members of the Gowanda Volunteer Fire Company coming and going during your event. They will make every effort to not disturb your event.
11. The Gowanda Volunteer Fire Company reserves the right to cancel hall reservations in the event of an emergency (ex. Natural disaster) with a full refund. Every effort will be made to avoid this.
12. Rental will not be secured until payment has been made in full.
13. Full payment is due at time of booking. Payment will be fully refundable up until ten (10) days prior to your event at which time your security deposit will become non-refundable for a cancelation.
14. Maximum seating capacity of Hall is 100 persons.
15. No rental will begin before 7am and all rentals will be cleaned up and out no later than 11pm.

Cost of rentals will be \$125 for a rental up to 6 hours, and \$200 for any rental more than 6 hours long.

Make checks payable to: GOWANDA VOLUNTEER FIRE DEPT.

There will also be a \$50 security deposit to be paid in addition to the above cost that will be returned if/when it has been determined that you have complied with the above agreement.

ICE IS AVAILABLE @ \$1.00 PER BAG. If more than 5 bags will be needed they must be requested ahead of time.
